LOANS & ADVANCES - Sanction of Advances for purchase of Motor Car and Personal Computer Advance to A.I.S. Officers – Enhancement - Orders - Issued.

ORDER:

In the reference 2nd read above, orders were issued raising the ceiling on advances for purchase of Motor Car and Personal Computer to Government Servants, subject to a maximum of Rs.3.00 lakhs or 15 times of basic pay or cost of the Car, whichever is less, in respect of Motor Car and for Personal Computer Advance, a maximum of Rs.50,000/-, with maximum 135 monthly installments for recovery of Principal and 65 installments for recovery of Interest thereon, for both the Advances.

2. The E.F.S. & T Department in the reference 3rd cited, have requested that the enhanced maximum limits of Motor Car Advance and Personal Computer Advance have to be made applicable to AIS Officers also by revising the orders issued in the reference 1st read above.

3. Government have examined the matter and after careful consideration, hereby order that the A.I.S. Officers drawing a Basic Pay of Rs.9,000/- per month shall be eligible for Motor Car Advance of Rs.3.00 lakhs or 15 times of basic pay or cost of the vehicle whichever is less. They are also eligible for Personal Computer Advance for Rs.50,000/-. The maximum monthly installments for recovery of Principal are 135 and for Interest thereon are 65, for both the Advances.

4. These orders shall come into force with effect from the date as applicable in the G.O. issued in the reference 2nd cited i.e. **01.04.2006**.
